### PART 4 – FEES

In addition to the base licence fee of **\$2,117.00** for the year, there is a yearly registration fee for the boat with the highest survey class endorsed on the licence\*. For the 2011/2012 licensing year, these fees are:

- For a boat surveyed to carry up to 6 unberthed passengers, **\$529.00**
- For a boat surveyed to carry between 7 and 12 unberthed passengers, **\$1,059.00**
- For a boat surveyed to carry more than 12 unberthed passengers, **\$2,117.00**

#### NOTE:

- If you are removing and adding a boat of the same survey class, the fee is **\$99.50**
- If you are removing a boat and adding a boat of a **higher** survey class **only the difference** in the fee is payable.

\* If the licence is endorsed to **use more than one boat at the same time**, fees will be applicable for each of those endorsed boats.

## PART 5 – LIABILITY INSURANCE DETAILS
