Completing the form

- It is necessary to provide all the information requested in the form or it will not be processed.
- You will find the registration number and tag numbers of your lost pots on the pot Registration Certificate.
- Please provide details of the general location where the pots were located when the loss occurred.
- **PLEASE RETURN YOUR REGISTRATION CERTIFICATE WITH THIS FORM, IT WILL BE REPLACED WHEN THE NEW TAGS ARE ISSUED.**

Processing of the form

This application can be processed either:

- In person at a PIRSA Fisheries & Aquaculture located in: Adelaide, Port Lincoln or Mount Gambier.
- By post to PIRSA Fisheries & Aquaculture, GPO Box 1625, Adelaide SA 5001

When submitting by post, the application will be processed as soon as possible after receipt, however, please allow 7 working days to receive your tags.

Temporary Tags

- The loss of tags must be reported to Fishwatch on 1800 065 522.
- Once reported you are entitled to use your registered pots for 48 hours, by fitting a temporary tag.
- After this time your pot(s) must be removed from the water until a replacement tag is received and attached.
- The temporary tag must be durable and must be marked with the registered holder's name, date of birth, registration number and contact telephone number.
