

I, BARRY ALAN GOLDSTEIN, Director Petroleum and Geothermal, Minerals and Energy Resources, Department of Primary Industries and Resources, in the State of South Australia, pursuant to the provisions of the *Petroleum Act 2000* (the Act) and all other enabling powers, for and on behalf of Paul Holloway, Minister for Mineral Resources Development (Minister), pursuant to delegated powers –

1. in fulfilment of Condition 4 of Petroleum Production Licences PPL 172 and PPL 189 hereby accept partial surrender of PPL 172 and PPL 189, pursuant to section 89 of the Act, with effect from 1 July 2008.

The total area of PPL 172 and PPL 189 respectively is reduced to 17.7 square kilometres and 8.27 square kilometres approximately, as a result of partial surrender of the licence areas.

2. hereby revoke Condition 4 of the licence conditions of PPL 172 and PPL 189 pursuant to section 76 (3) (b) of the Act, following the fulfilment of the conditions of the Deed dated 1 May 2001, as subsequently amended by Deeds to Amend Fixed Factor Area Deeds dated 24 October 2005.
3. pursuant to section 83 of the Act, hereby divide the area of PPL 172, consequently forming three new licence areas as described as Areas A, B and C in Schedule 1 hereto.

Area A of the divided licence area shall retain the existing designation as PPL 172. This area is reduced to 16.39 square kilometres approximately, as per the attached Schedule 2 and Map, as a result of partial surrender of the licence area.

4. pursuant to section 83 of the Act, hereby divide the area of PPL 189, consequently forming two new licence areas as described as Areas A and B in Schedule 3 hereto.

Area A of the divided licence area shall retain the existing designation as PPL 189. This area is reduced to 7.06 square kilometres approximately as per the attached Schedule 4 and Map, as a result of partial surrender of the licence area.

5. pursuant to section 82 of the Act, hereby consolidate the adjacent areas of Area B (ex PPL 172) and Petroleum Production Licence PPL 82, so forming Petroleum Production Licence PPL 235 as a new licence in continuity of Area B (ex PPL 172) and PPL 82.
6. pursuant to section 82 of the Act, hereby consolidate the adjacent areas of Area C (ex PPL 172) and Area B (ex PPL 189), so forming Petroleum Production Licence PPL 236 as a new licence in continuity of Area C (ex PPL 172) and Area B (ex PPL 189).

**OPERATIVE PROVISIONS**

1. Pursuant to the Minister's offers to grant the production licences identified in the attached schedule (each a "Licence") to the Licensees, the Licensees hereby agree and undertake to:

1.1 make application to the Minister to surrender such part (if any) of each licensed area ("Surrendered Areas") on or before the date specified for each Licence in the fourth column of the schedule so that the remaining area of each Licence is no greater than the combined total of:

- (a) the area under which proved and probable reserves of petroleum occur including areas under which proved and probable reserves of petroleum can be demonstrated to have occurred prior to the initiation of production from the field; and
- (b) surrounding land identified by the Licensees equal in size to the area mentioned in 1.1(a);

1.2 surrender the least number of separate areas where technically appropriate and with regard to good petroleum field practice and defined by parallels of latitude and meridians of longitude expressed in the Geocentric Datum of Australia (GDA), 1994.

2. The Parties (which in this Deed shall mean the Minister and each of the Licensees) agree that the Licensees will have no right to retain title over the Surrendered Areas as a retention licence under any legislation which allows for such licences.

3. If the Minister following a technical review with the Licensees forms the view that the area or areas identified by the Licensees under 1.1(a) is or are not technically justified having regard to the matters referred to at 3.1 and 3.2, the Parties agree to appoint a suitably qualified expert (whose decision shall be final and binding), the costs of whom shall be borne equally between the Minister on the one hand and the Licensees on the other, to determine such area or areas. In the event the Parties fail to agree on the appointment of a suitably qualified expert, the expert shall be appointed by the President of the Society of Petroleum Engineers or his or her nominee. The expert shall, in making his determination, have regard to:

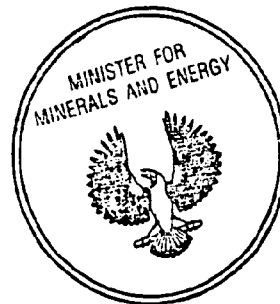
- 4. This Deed may not be amended or varied except by the written agreement of all Parties.
