- For a boat surveyed to carry more than 12 unberthed passengers, \$1553

NOTE:

- If you are removing and adding a boat of the same survey class, the fee is **\$93.50**
- If you are removing a boat and adding a boat of a **higher** survey class only the difference in the fee is payable.
