 - 2 3 All charges incurred by the Licensee in obtaining and maintaining the Security shall be met by the Licensee.
 - 2 4 If upon expiry, this Licence is not renewed and the Minister is satisfied that there are no further obligations under this Licence or the Act, the Minister will return the Security to the Licensee

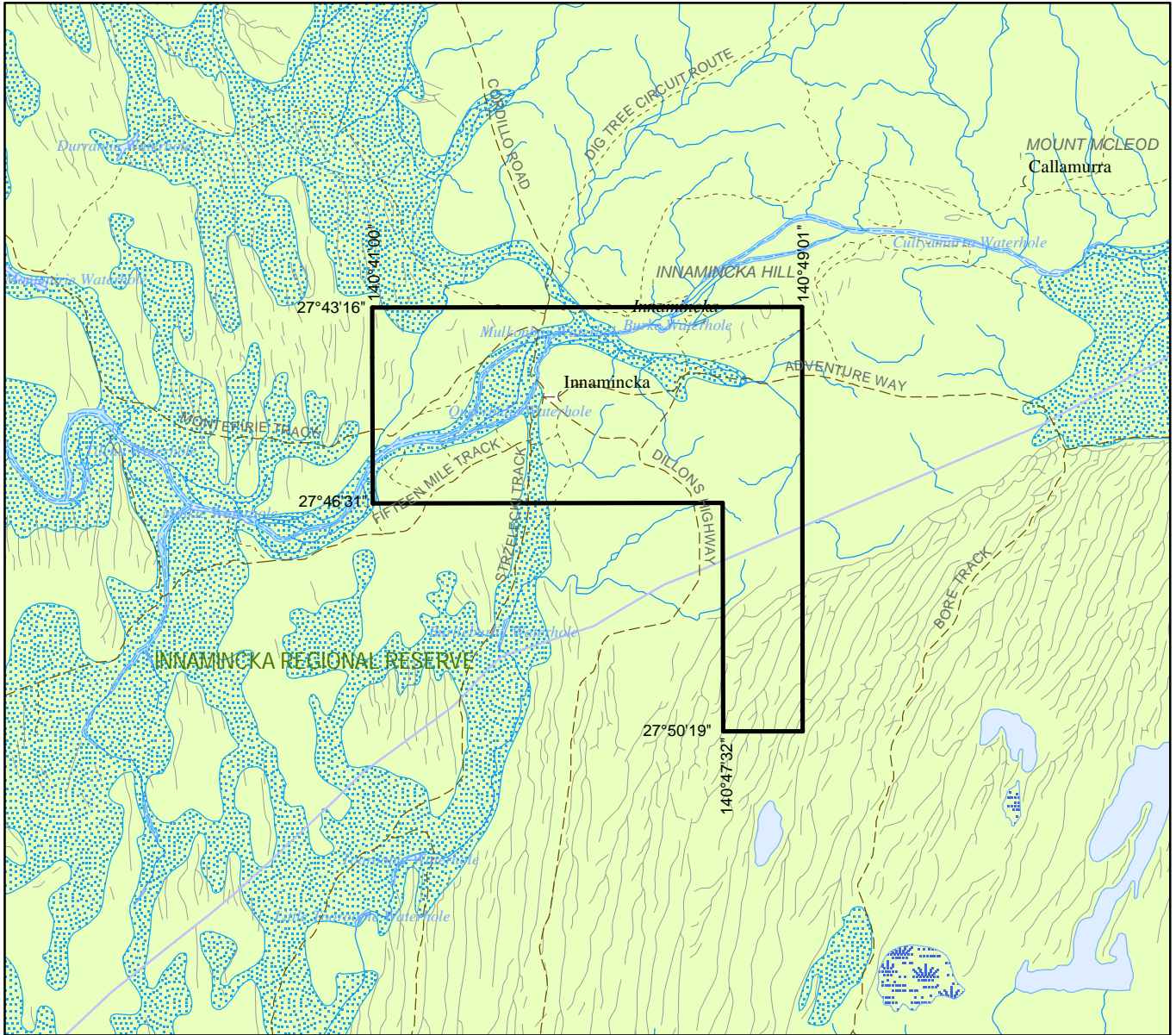

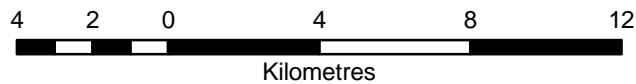


