NOTICE TO THE MINISTER FOR AGRICULTURE, FOOD AND FISHERIES

ELECTION BY A WINEMAKER OR GROWER OF GRAPES TO PAY A FIXED CONTRIBUTION

INFORMATION

Regulation 5(1) (c) of the *Primary Industry Funding Schemes (Barossa Wine Industry Fund) Regulations 2007* provides that if a Barossa winemaker or grower elects, by written notice given to the Minister not later than 30 June 2008, to pay a fixed contribution for each prescribed period- the winemaker or grower must contribute \$48,000 for the grapes delivered during the prescribed period.
