APPLICATION TO TRANSFER BLUE CRAB QUOTA UNITS

INSTRUCTIONS FOR COMPLETION OF APPLICATION

1. You must forward an application fee of \$158 with this application.
2. A separate application form is to be completed for each proposed transfer to a different licence holder.
3. **Transfer of blue crab quota will not alter the annual licence fees that apply. Your fees will not be recalculated.** You will still be charged the full licence fee, including any outstanding instalments, for the remainder of the year. Licence holders should consider these fees when negotiating the transfer price of blue crab quota.
4. **All applications must be completed in full before being lodged** with PIRSA Fisheries & Aquaculture. Applications that are not complete, or that do not have correct documentation attached, will be returned. Please contact PIRSA Fisheries & Aquaculture on (08) 8204 1370 if you have any queries. Both parties **MUST** initial each page (bottom corners) where indicated.

INFORMATION ABOUT TRANSFER

1. The *Fisheries Management (Blue Crab Fishery) Regulations 2013* provide that where a quota transfer takes place the Minister must vary the licence conditions of the relevant licences to also adjust the pot entitlement, in accordance with the formula in regulation 9(3) of those Regulations. Therefore, if one or both of the licences in this transfer is a licence for the Blue Crab Fishery and this application is approved, your quota unit entitlement will be adjusted and your pot entitlement will also be adjusted.
2. Quota entitlements can be transferred in **whole uncaught units only**.
3. Quota entitlements should not be fished until you have received written confirmation that the entitlements have been endorsed on the licence.
