**APPLICATION TO TRANSFER  
ROCK LOBSTER QUOTA UNITS AND / OR POTS**

**INSTRUCTIONS FOR COMPLETION OF APPLICATION**

1. You must forward an application fee of \$172 with this application.
2. A separate application form is to be completed for each proposed transfer to a different licence holder.
3. **Transfer of rock lobster will not alter the annual licence fees that apply. Your fees will not be recalculated.** You will still be charged the full licence fee, including outstanding instalments, for the remainder of the year. Licence holders should consider these fees when negotiating the transfer price of rock lobster quota.
4. **All applications must be completed in full before being lodged.** Applications that are not complete, or that do not have correct documentation attached will be returned. Please contact PIRSA Fisheries & Aquaculture if you have any queries. Both parties **MUST** initial each page (bottom corners) where indicated.

**INFORMATION ABOUT TRANSFER**

1. The minimum pot holding is 20 pots. However, you may temporarily transfer below this pot holding. If you make an application that results in the number of pots endorsed on your licence being temporarily less than 20 pots, you are not permitted to undertake any fishing activity pursuant to your licence or transfer quota. This includes fishing for Scalefish species.
2. In addition to above:
  - a. To fish for Rock Lobster, the minimum quota holding is 320 units in the Region you will fish for Rock Lobster.
  - b. To fish for species other than Rock Lobster / retain them as by-catch (in either Region), the minimum quota holding is 320 Inner Region units.
3. If you want to transfer some units or pots permanently and some units or pots temporarily, you will need to complete two separate forms.
4. The maximum pot holding is 100 pots.
5. Quota entitlements can be transferred in **whole uncaught units only**.
6. Quota entitlements should not be fished until you have received written confirmation that the entitlements have been endorsed on the licence.
