INSTRUCTIONS FOR COMPLETION OF APPLICATION

1. You must forward an application fee of \$158 with this application.
2. A separate application form is to be completed for each proposed transfer to a different licence holder.
3. **Transfer of giant crab quota will not alter the annual licence fees that apply. Your fees will not be recalculated.** You will still be charged the full licence fee, including any outstanding instalments, for the remainder of the year. Licence holders should consider these fees when negotiating the transfer price of giant crab quota.
4. **All applications must be completed in full before being lodged** with PIRSA Fisheries & Aquaculture. Applications that are not complete, or that do not have correct documentation attached, will be returned. Please contact PIRSA Fisheries & Aquaculture on (08) 8204 1370 if you have any queries. Both parties **MUST** initial each page (bottom corners) where indicated.

INFORMATION ABOUT TRANSFER

1. The giant crab fisheries are managed as two separate fishing zones (the southern and northern fishing zones) in the same way that the rock lobster fishing zones are managed. A separate Total Allowable Commercial Catch is set for each fishing zone and quota units are allocated separately for each zone.
2. Giant crab quota units can only be transferred to a licence if that licence allows access to giant crabs in the same zone as the licence from which the quota units are to be transferred. This means that giant crab quota units can be transferred from a SZRLF licence to another SZRLF licence, or from one NZRLF licence to another, but giant crab quota units cannot be transferred from a SZRLF licence to an NZRLF licence, or vice versa. However, giant crab quota units can be transferred from a Miscellaneous Fishery licence to either a SZRLF or a NZRLF licence, and vice versa, provided the quota units remain in the same fishing zone.
3. Only unfished quota units can be transferred. Unfished quota can be permanently or temporarily transferred to **2 decimal places**.
4. Quota entitlements should not be fished until you have received written confirmation that the entitlements have been endorsed on the licence.
