

## ***Fisheries Management (Marine Scalefish Fishery) Regulations 2017***

### Regulations 25A, 25B and 25C

---

#### Revocation

The Determination made for the purpose of regulation 21A, 21B and 21C dated 1 July 2021 is hereby revoked.

---

#### Determination

For the purpose of Regulations 25A, 25B and 25C relating to information to be provided to the Department – Snapper, Southern Calamari, Southern Garfish- I make the following determinations -

#### **Regulations 25A, 25B, 25C (Information to be provided—Snapper, Southern Calamari, Southern Garfish)**

The holder of the licence in respect of the fishery, or registered master of a registered boat used under such a licence, must comply with the following provisions within specified fishing zones of the *Fisheries Management (Marine Scalefish Fishery) Regulations 2017*:

- (1) Before commencing fishing activities in the Gulf St.Vincent and Kangaroo Island Fishing Zone and Spencer Gulf Fishing Zone involving the take of Snapper, Southern Calamari or Southern Garfish, the licence holder or registered master must notify the Department via FISHWATCH on 1800 065 522, or via the Commercial Fishing SA Application, of:
  - (i) The name of the person conducting the fishing activity; and
  - (ii) The contact number for the person making the telephone call or providing information via the App; and
  - (iii) The licence number relating to the activity to be undertaken; and
  - (iv) The closest landmark or port of departure; and
  - (v) The date and time at which the fishing activities are to be engaged in; and
  - (vi) The fishing zone in which the fishing activities are to be engaged in; and
  - (vii) The name of the registered master of the boat.
- (2) Before the commencement of fishing activities in the South East Fishing Zone or West Coast Fishing Zone involving the take of Snapper the holder of this licence or registered master must inform the Department via FISHWATCH on 1800 065 522, or via the Commercial Fishing SA Application, of:
  - (i) The name of the person conducting the fishing activity; and
  - (ii) The contact number for the person making the telephone call or providing information via the App; and
  - (iii) The licence number relating to the activity to be undertaken, and
  - (iv) The closest landmark or port of departure; and
  - (v) The date and time at which the fishing activities are to be engaged in; and

- (vi) The Fishing Zone in which the fishing activities are to be engaged in; and
  - (vii) The name of the registered master of the boat.
- (3) Prior to entering a different Fishing Zone from where Snapper, Southern Calamari or Southern Garfish on board the vessel have been taken on the same fishing trip, the licence holder or registered master must notify the Department via the Commercial Fishing SA App or FISHWATCH on 1800 065 522, of:
- (i) The name of the person making the telephone call or providing information via the App;
  - (ii) The contact number of the person making the telephone call or providing information via the App;
  - (iii) The name of the holder of the licence, or the registered master operating the vessel;
  - (iv) The licence number being fished;
  - (v) The estimated weight of Snapper, Southern Calamari or Southern Garfish on board the vessel; and
  - (vi) The number(s) of the tags provided by the Department used to seal the receptacle(s) in which the Snapper, Southern Calamari or Southern Garfish are stored; and
  - (vii) The Fishing Zone the fisher is entering and will take quota species from.
- (4) At least 30 minutes before departing the point of landing after a fishing trip where Snapper, Southern Calamari or Southern Garfish have been taken in the Gulf St. Vincent and Kangaroo Island Fishing Zone, or Spencer Gulf Fishing Zone the licence holder or registered master must inform the Department via FISHWATCH on 1800 065 522, or via the Commercial Fishing SA Application, of:
- (i) The name of the person who conducted the fishing activity; and
  - (ii) The date and time when departing the point of landing; and
  - (iii) The port or closest landmark to place of landing; and
  - (iv) The nomination of intention to apply one of the following actions:
    - (a) To seal receptacles with a tag (s) issued by the Department before departing the point of landing and to provide the tag numbers used; or
    - (b) To provide an estimated total weight of all Snapper, Southern Calamari or Southern Garfish taken before departing the point of landing. The fisher is to ensure the estimated weight is within 10% of the actual landed weight.
- (5) At least 30 minutes before departing the point of landing in the South East Fishing Zone or West Coast Fishing Zone involving the take of Snapper, licence holder or registered master must inform the Department via FISHWATCH on 1800 065 522, or via the Commercial Fishing SA Application, of:
- (i) The name of the person who conducted the fishing activity; and
  - (ii) The date and time when departing the point of landing; and
  - (iii) The port of landing or closest landmark of landing; and
  - (iv) The licence holder or registered master to nominate one of the following actions:
    - (a) To seal receptacles with a tag (s) issued by the Department before departing the point of landing and to provide the tag numbers used; or

(b) To provide a weight of catch for all Snapper before departing the point of landing. The fisher is to ensure that this weight is within 10% of the actual landed weight.

- (6) The holder of the licence or registered master under such a licence subject to a condition fixing a Snapper, Southern Calamari or Southern Garfish quota entitlement, or registered master under such a licence, must immediately notify the Department via FISHWATCH on 1800 065 522, or via the Commercial Fishing SA Application of any change to information already submitted to the Department under this determination.
