Further to our phone call, I note that the Federal Minister for Infrastructure, Transport, Regional Development and Local Government, the Hon Catherine King MP recently announced that the Building Better Regions Fund (BBRF) will be discontinued, which includes BBRF Round 6.

I want to reaffirm the Malinauskas Labor Government's commitment of up to \$2.7 million towards the redevelopment of the Mount Gambier Saleyards project. The current funding commitment is maintained subject to your Council securing Commonwealth funding.
