### Processing of the form

- In person at a PIRSA Fisheries & Aquaculture office located in: Adelaide (2 Hamra Avenue, West Beach. SA 5024), Mount Gambier, Port Lincoln, Kingscote, Clare or Struan. **Payment by credit card (Visa/Mastercard only) or EFTPOS**
- By post to PIRSA Fisheries & Aquaculture, GPO Box 1625, Adelaide SA 5001. On receipt of the application, we will contact you to obtain payment by credit card as **cash and cheques are no longer accepted.**

When submitting by post, the application will be processed as soon as possible after receipt, however, please allow 7 working days to receive your tags.
