Determination under the Freedom of Information Act 1991

I refer to your application made under the *Freedom of Information Act 1991* which was received by the Department of Primary Industries and Regions (PIRSA) on 14 October 2020, seeking access to the following:

"Documents that quantify

- 1. The names of all border stations used to enforce the Keep SA fruit fly free programme.
- 2. The specific geographic location of each border station which are utilised to enforce the Keep SA fruit fly free program.
- 3. Which border stations are Zero Tolerance.
- The location of warning signage Positioning of signage on approach roads warning approaching vehicles of each of the vehicle checkpoints and the exact wording of each of the signs.
- 5. If the Zero Tolerance policy for fines at the Yamba Quarantine station is sign posted prior to the station warning approaching vehicles.
- 6. Does the SA fruit fly free programme enforce the legislation with inwards and outwards of the SA border?
- 7. Of the 159 explation notices which have been withdrawn from the Yamba checkpoint since the commencement of the keep SA fruit fly free program, what are the three most common reasons for the withdrawal of the notice."

	The other two most common reasons fall into the category of trifling, pursuant to the <i>Expiation of Offences Act 1996</i> . These reasons may be based on issues of safety or ambiguity of evidence, however, each case and circumstances is scrutinised on its own merits.

Audit conducted on 24th and 25th September 2018.


