I write to inform you of my decision to support the recovery and ongoing vitality of the Riverland grape and wine sector by providing \$100,000 (excluding GST) towards the development of an industry led blueprint to identify priority projects and actions to guide the sector over the next ten years.

It is envisaged the *Riverland Wine Industry Blueprint* will be delivered under the following principles:

- Establishment of a high-level steering committee to provide governance and direction to the blueprint. This would include an independent chairperson jointly agreed by Riverland Wine and the SA Government.
- o Appointment of an independent consultant to drive discovery, engagement and creation of the blueprint.
- Development of positioning papers for each part of the sector which will be used to inform the whole of supply chain engagement process which will include workshops, surveys and stakeholder meetings.
- Launch at an industry event with relevant extension and promotion materials produced.

Jo Collins, Executive Director, Industry, Strategy and Partnerships will be in contact with you to develop a suitable agreement in relation to this new support.

I look forward to continuing to work with the Riverland grape and wine industry into the future.



The Riverland wine-producing region is incredibly important to the Australian wine industry in terms of scale, economic contribution, diversity, export value, technology and structural change and innovation. The region is facing some of the toughest market conditions in its history with lowered commercial red wine grape prices, full inventory and global transport disruptions severely impacting wine businesses and the broader economy in the region.

Riverland wine growers and wineries understand they must diversify markets and product mix. Focussing on greater product diversity, upskilling for market growth, and adopting new and environmental approaches to viticulture are crucial to the region's economic prosperity and community wellbeing.

In support of the Riverland region, we invite you and other representatives to tour the Riverland to gain insight into the severity of the crisis. The visit will open the opportunity discuss co-investment and short-term support to help our wine businesses transition through the next two years of trading.

The program will inform why current economic and biological conditions are not business as usual and, include a tour of the region's largest winery, a visit to a significant grape growing property and a luncheon with the region's key stakeholders.

In addition, Riverland Wine has commenced working with its partners on a local regional response to the proper removal of grapevine material and resting of vineyards that will assist biosecurity. Investment in R&D to fill the knowledge gaps of resting vineyards and, assisting winegrape growers with recovery and resilience is critical.

RIVERLAND WINE — A UNIQUE MAJOR WINE REGION



The Riverland wine-producing region is incredibly important to the Australian wine industry in terms of scale, economic contribution, diversity, export value, technology and structural change and innovation.

Riverland Wine also plays a major part in the success and growth of the South Australian wine industry and state economy is a significant contributor to the Food, Wine and Agribusiness Growth State Plan to grow the sector to \$23 billion by 2030.

Extending for 330 kilometres along the Murray River, it is the largest Australian wine region by size, volume of crush (31%), number of growers (936), and commercial wine grape varieties (85). The wine from the Riverland is exported to over 100 countries.

ISSUES AND CHALLENGES

The Riverland red wine commercial market is very different to other wine regions and is facing some of the toughest market conditions in its history. The negative impact of China tariffs and the supply challenges resulting in lower grape prices are severely impacting wine business and the broader economy in the region. No Shiraz or Cabernet grower is unaffected. An estimated 40% of Shiraz and Cabernet wine grapes produced in the region have no domestic or export market contracts and, prices for the remainder are commercially unsustainable. The region will be affected for 2-4 years.

Australian wine is temporarily uncompetitive in the global commercial wine market due to transport issues that have disproportionately affected Australia compared to our competitors just as we lost the China market. Shipping, inflation and On-costs continue to have a serious impact.



A SOLUTION

The Riverland Wine growers and wineries understand they must diversify markets and product mix.

They have invested tens of millions of dollars of their own money in recent years in this regard.

Due to the major market challenges, they are now seeking co-investment to tailor wine export programs and to further improve adaptation of grape and wine production.

Focussing on greater product diversity, upskilling for market growth and adopting new and environmental approaches to viticulture are crucial to the region's future economic prosperity and community wellbeing.

Riverland Wine is seeking short term support to manage inventory and help transition it through the next two years of trading.

Our two key priorities for the South / Federal Australian Government to consider are:



Assist wineries to sell more wine in new and existing markets



Support growers to transition to new product mixes

PARTNERING WITH GOVERNMENT

Greater export marketing to sell more wine in new markets

- Increased focus from the State Government through PIRSA and the Department of Trade and Investment to support Riverland Wine with sales and movement of red wine.
- Substantial financial support as a percentage of excise for the marketing and sale of Riverland wine to new markets with a focus on exports.

Regional producer and grower's support

Riverland Wine has commenced working with its partners on a local regional response. The region and the industry have invested millions of dollars and significant resources. To continue this investment and address the challenges, we are seeking new co-investment with the South Australian and/or Federal Governments to provide matching support to growers for some or all the following activities:



Financial support for growers to respond to challenging conditions.



Costs of not growing.



Enabling a faster recovery. No container cancellations.



Proper removal of grapevine material and resting of vineyards that will assist biosecurity.



Strategies to grow consumption domestically. Buy Australian Wine campaign.



Potential water buy-backs with transitional requirements.

We are also seeking investment in R&D to fill knowledge gaps of resting vineyards that has commenced but requires a more active process.

Improved market information to support wine transportation and sales

Riverland growers and producers are concerned about their ability to make effective decisions considering the uncertainty about freight.

We are seeking that the State Government provide information on the changing freight situation that provides at least monthly updates to the growers and producers of the region to increase their situational transparency and therefore effectiveness of decision making.

Financial support

Funding for winegrape growers to assist with the recovery and resilience to extremely challenging market conditions.

We are seeking \$5 million over 3 years.

Dear Ms Rowe Syndall,

Thank you for your letter of 9 November 2022 to the Premier, the Hon Peter Malinauskas MP about the challenges faced by your members owing to the looming oversupply of red wine grapes in Australia.

I commend you for the support you are providing to your members, particularly the recent outlook workshops in Renmark and Waikerie. I learned firsthand when I visited the Riverland recently and met with yourself and representatives of the Riverland grape growers and wine makers of the many challenges the Riverland wine producers are facing with oversupply of red wine grapes and near record river levels approaching.

South Australian Government agencies are working closely with local government and relevant community groups and industry bodies to minimise the impact of the increased flows on residents, workers, businesses, primary producers and tourism with immediate priority given to protecting people, infrastructure and property.

Your members may be interested to know that River Murray primary producers are now able to apply for funding to assist with the costs associated with flood impacts to irrigation infrastructure and electricity supply. More information can be found at pir.sa.gov.au.

Regarding your request for assistance, I have recently written to my federal counterpart, Senator the Hon Murray Watt, to undertake discussions regarding a nationally consistent strategy to manage solutions for the oversupply issue and impacts on grape growers and winemakers. This is important as the oversupply is truly a national issue that requires a holistic approach from multiple state governments, the Commonwealth Government and national, state and regional industry bodies. Minister Watt has indicated that he will remain in contact with me as industry conditions evolve ahead of the 2023 vintage and welcomes suggested policy approaches.

We understand that your growers and winemakers are facing unprecedented challenges. The Family and Business Support mentor program and the Rural



Financial Counselling Service have been mobilised to provide support to impacted primary producers. I encourage you to continue to promote these services as we work towards a meaningful strategy to support the wine industry to return to a sustainable supply and demand balance.

I understand that a meeting with senior Departmental officers and Riverland Wine is taking place today. I am keen to ensure that my office alongside the Department of Primary Industries and Regions are in active discussions with Riverland Wine to address the issues being faced by grape growers in the Riverland region.

Once again, thank you for writing to me on this important matter.

Dear Minister Scriven,

It was fantastic to see the Premier visiting the Riverland yesterday. An appropriate package to provide support for those people who are affected by floods is needed and we appreciate the Premier's consideration on this.

I also draw to your attention that the rising river levels and heavy rains in the Riverland is set to significantly compound *the toughest ever market conditions Riverland wine growers are facing.*

An estimated 40% of Shiraz and Cabernet wine grapes produced in the region have no domestic or export market contracts and prices are commercially unsustainable. *Winegrowers are at a crisis point.*

The negative impact of China tariffs and the supply challenges resulting in lower grape prices are already severely impacting wine business and the broader economy in the Riverland region.

We have requested that the Premier considers *financial support for growers to respond to challenging conditions* $(\$750k \ to \ \$1m)$ and *support to remove grapevine material and resting of vineyards that will assist biosecurity* (\$750k - \$1m) in the Riverland support package that will be announced next week.




