# APPLICATION TO TRANSFER UNIT ENTITLEMENTS

## INSTRUCTIONS FOR COMPLETION OF APPLICATION

1. A separate application form is to be completed for each proposed transfer to a different licence holder.
2. **All applications must be completed in full before being lodged** with PIRSA Fisheries & Aquaculture. Applications that are not complete, or that do not have correct documentation attached, will be returned. Please contact PIRSA Fisheries & Aquaculture on (08) 8204 1370 if you have any queries. Both parties **MUST** initial each page (bottom corners) where indicated.

## INFORMATION ABOUT TRANSFERS

1. If you want to transfer some units permanently and some units temporarily, you will need to complete two separate forms.
2. Only available units can be transferred.
3. Unfished nights at the end of the fishing season (31 July) are not added to the total allowed nights in the following fishing season (commencing 1 November the same year).
4. Unit entitlements should not be fished until you have received written confirmation that the entitlements have been endorsed on the licence.
