Determination under the *Freedom of Information Act 1991*

I refer to your application made under the *Freedom of Information Act 1991* which was received by the Department of Primary Industries and Regions (PIRSA) on 16 March 2021, seeking access to the following:

"A list of all organisations and individuals that receive invitations to PIRSA's fruit fly committee meetings."

Timeframe: 16/09/2019 to 16/03/2021

Pursuant to Section 14A of the Freedom of Information Act, the legislative timeframe in which to provide a determination was extended until 17 May 2021.

Accordingly, the following determination has been finalised.

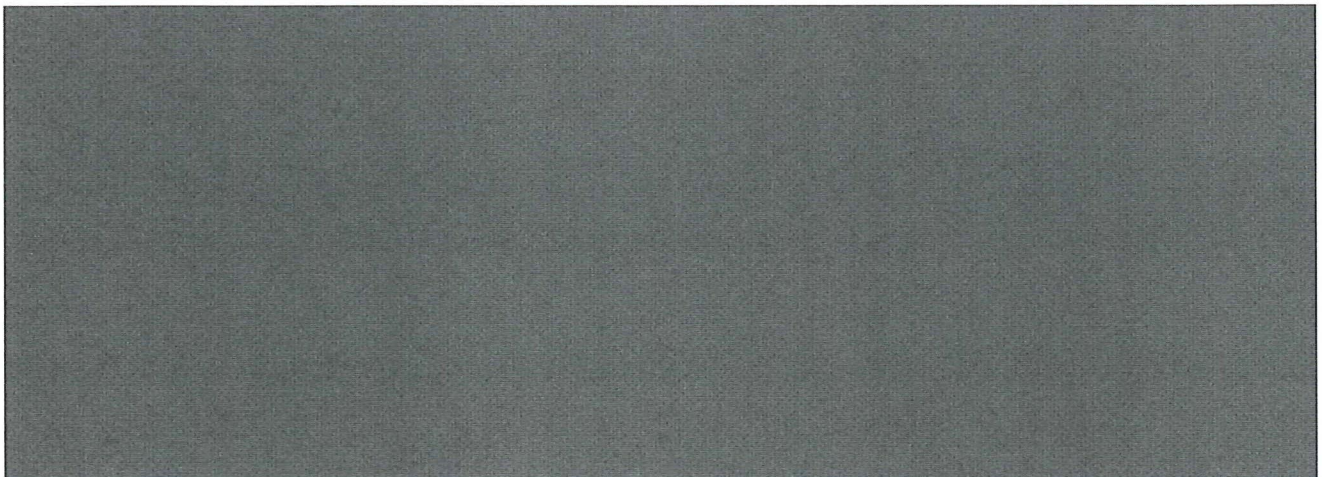

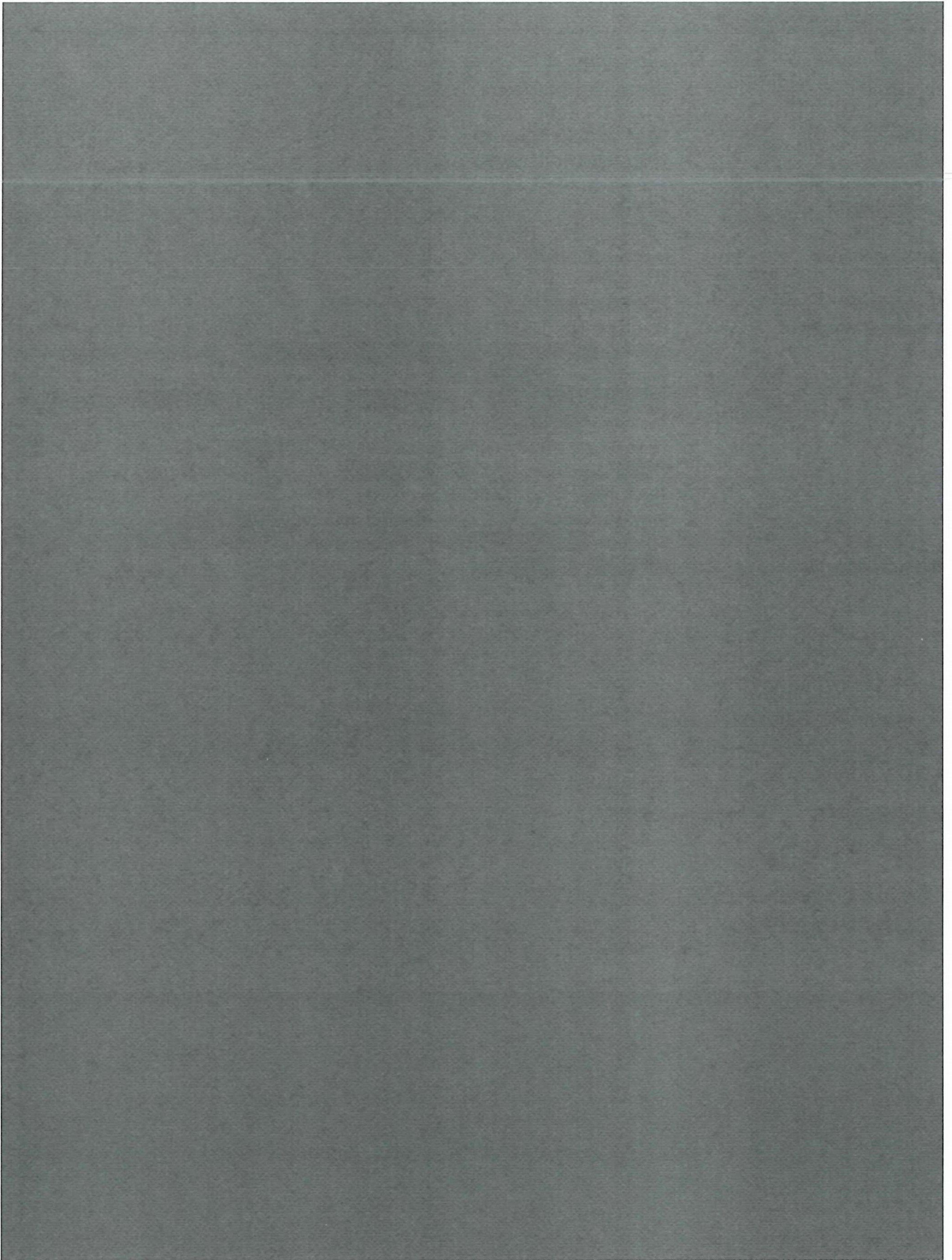
