 - The redaction in the sixth line and the first redaction of the seventh line in "Required Attendees" refers to a representative of Riverland Wine and a private email address.
 - The redaction in "Optional Attendees" is a different email address of a required attendee.
- Document 5:
 - The first redaction in the fifth line of the email recipients is the name of a representative of the Commonwealth Department of Agriculture.
 - The redactions in the tenth and eleventh lines of the email recipients refers to a representative of Riverland Wine and a private email address.
 - The information removed from page 2 consists of the names of representatives of Local Government and Summer Fruits Australia.
- Document 6:
 - The information removed consists of the names of representatives of Berri Barmera Council and SA Fresh Fruit Growers.
- Document 7:
 - The information removed is the name of a representative of Summer Fruits Australia.


