Determination under the Freedom of Information Act 1991

I refer to your application made under the *Freedom of Information Act 1991* received by the Office of the Minister for Primary Industries and Regional Development, Minister for Forest Industries on 30 November 2023 requesting access to the following:

"Please provide all documents, including but not limited to emails, text messages, diary entries, briefings, notes on any other form of communication between the Minister for PIRD and Forest Industries, including any other staff member, and the Member for Newland and/or her office."

Timeframe: 09/08/2023 to 30/11/2023

Accordingly, the following determination has been finalised.

The information removed from the above documents is pursuant to Clause 6(1) of Schedule 1 of the Freedom of Information Act which states:

"6 - Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."

The information removed consists of the names, home addresses, private email address and mobile telephone number relating to the individuals concerned. Pursuant to Section 27 of the Freedom of Information Act, consultation was undertaken with the third party to which the documents relate and consent was not provided to release this information.

Accordingly, it is considered that disclosure of this information would be an unreasonable intrusion into the privacy rights of the individuals concerned.

If you are unhappy with this determination you are entitled to exercise your rights of external review with the Ombudsman SA. Alternatively, you can apply to the South Australian Civil and Administrative Tribunal (SACAT). If you wish to seek a review, you must do so within 30 calendar days of receiving this determination.

I am also interested to know if there is any way of treating the trees if there is a mass clearing planned rather than removing them.
