2024 Vintage – Wine Industry Fund Contribution Rates

- Contributions are determined by the region in which the grapes are grown.
- In addition to the relevant regional Wine Industry Funds, contributions to the SA Grape Growers Fund are payable on all grapes grown anywhere in South Australia (excluding those grown by winemakers).
- Contributions for 2024 vintage are required to be paid to the Department of Primary Industries and Regions (PIRSA) by 30 June 2024.

Grower Contribution	Paid by the grower. Collected by the winemaker as a deduction from the amount paid to the grower for the		
	purchase of grapes and remitted to PIRSA.		
Winemaker Contribution (purchased	Paid to PIRSA by the winemaker on all grapes purchased.

Winemaker Contribution (own grapes)	Paid to PIRSA by the winemaker for grapes grown by the winemaker.		
Minimum Winemaker Contribution	The minimum amount payable by a winemaker.		
Clare Valley minimum winemaker contribution	 \$500 if winemaker has a vineyard or processing facility in the Clare Valley, but no cellar door. \$1,000 if winemaker has a vineyard or processing facility and a cellar door in the Clare Valley. No minimum: a winemaker without a vineyard, wine-making facility or cellar door in the Clare Valley is not obliged to pay the minimum contribution. 		
Maximum Contribution	The maximum contribution payable by a single business (grower or winemaker). Note that grower contributions collected by a winemaker are to be remitted in addition to the maximum contribution payable by the winemaker.		
Brokers and intermediaries	Winemakers are responsible for collecting and remitting grape grower contributions on all grapes they purchase. Brokers or other intermediaries should ensure that deducted contributions are clearly identified on documentation provided to growers.		
Contract Winemaking	Winemakers are responsible for collecting and paying contributions. Where the owner of the grapes contracts a winery to process grapes on their behalf, the owner of the grapes is deemed to be the winemaker and is required to make the appropriate payments to PIRSA.
