**Determination under the *Freedom of Information Act 1991***

I refer to your application made under the *Freedom of Information Act 1991* which was received by Primary Industries and Regions SA (PIRSA) on 22 May 2018, seeking access to the following:

*"Since 17 March 2018, copies of any and all documents (including but not limited to physical, electronic or written briefs, minutes, emails, and any other documents) which lists or provides the name and position title of all senior Human Resources staff within the agency. Timeframe: 17/3/18 to 22/5/18."*

On 22 May 2018, contact was made with your office by PIRSA's Freedom of Information and Privacy Officer seeking clarification of your request. It was confirmed that you are specifically referring to Executive with HR responsibilities, managers and team leaders or similar. It was also clarified that an organisational chart, providing names and position titles, would adequately address the request.

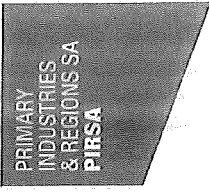
