NOTICE TO BLUE CRAB FISHERY LICENCE HOLDERS

Public consultation on draft Management Plan for the South Australian Commercial Blue Crab fishery

Dear Licence holder

I write in relation to the release of a draft *Management Plan for the South Australian Commercial Blue Crab Fishery* ("the Management Plan or "the Plan") for a statutory public consultation period of not less than two months, closing at 11.59pm on 3 March 2024.

It is proposed that the draft Management Plan will apply for a term of 10 years, replacing the current Management Plan which came into effect on 1 January 2018, and following an 18 month extension, expires 30 June 2024.

Consistent with section 49 of the *Fisheries Management Act* 2007 (the Act), a review of the current Plan was conducted by members of the Blue Crab Fishery Management Plan Review Committee (BCFMPRC) which has been established by the Minister for Primary Industries and Regional Development under section 20 of the Act. This review concluded that the current Management Plan should be replaced.

A replacement draft Management Plan was subsequently prepared by the Department of Primary Industries and Regions (PIRSA) on behalf of the Minister pursuant to section 44(1)(b) of the Act and in consultation with the BCFMPRC.

A report has also been prepared by PIRSA on behalf of the Minister pursuant to section 44(2) of the Act to accompany the draft Management Plan. The report provides an explanation of the purpose and effect of the draft Management Plan, and a summary of the relevant background and issues and the analysis and reasoning applied in its formulation.

Pursuant to section 44(3)(b) of the Act, and as delegate of the Minister for Primary Industries and Regional Development, I am releasing the draft Management Plan for public consultation.

Copies of the draft Management Plan and the report will be available for inspection at PIRSA at 2 Hamra Ave, West Beach SA 5024 during the consultation period during normal business hours.

I now refer the draft Plan and report to you and invite you as an interested person to make written submissions in relation to the draft Management Plan by **11.59pm 3 March 2024.**
