**APPLICATION TO TRANSFER  
ABALONE QUOTA UNITS**

**INSTRUCTIONS FOR COMPLETION OF APPLICATION**

1. You must forward an application fee of \$172 with this application.
2. A separate application form is to be completed for each proposed transfer to a different licence holder of one or more types of quota.
3. **Permanent and/or temporary transfer of abalone quota units will not alter the annual licence fees that apply. Your fees will not be recalculated.** You will still be charged the full licence fee as notified at the time of renewal, including any outstanding instalments. Licence should consider these fees when negotiating the transfer price of abalone quota.
4. **All applications must be completed in full before being lodged** with PIRSA Fisheries & Aquaculture. Applications that are not complete, or that do not have correct documentation attached, will be returned. Please contact PIRSA Fisheries & Aquaculture on (08) 8207 5332 if you have any queries. Both parties **MUST** initial each page (bottom corners) where indicated.

**INFORMATION ABOUT TRANSFER**

1. Quota entitlements are reallocated and endorsed on licences prior to 1 January each year in the Western Zone Abalone Fishery, for the start of the quota year on 1 January. Temporary quota unit transfers therefore only apply until the end of the year in which the transfer is made – i.e. until 31 December.
2. There are minimum permanent quota unit holdings that apply. If a licence has less than the minimum permanent quota unit entitlement, it is illegal to take abalone pursuant to those units. The minimum permanent quota unit entitlements that apply for each class of abalone and each region are set out in the table below.

Blacklip abalone	25
Greenlip abalone	27.5

3. Only permanent quota unit transfers are considered for determining whether the permanent quota unit entitlement for a class of abalone has been reduced to less than the minimum permanent quota unit entitlement (the number specified in column 2 of the table above).
4. Your permanent quota unit entitlement is calculated as the sum of the 'current owned units' on the licence extract certificate issued to you at the beginning of the current quota period and the net adjustment as a result of a **permanent** quota transfer(s) during the same quota period.
5. **Only unfished quota can be transferred.** Unfished quota can be permanently or temporarily transferred to **2 decimal places**.
6. Quota unit entitlements should not be fished until you have received written confirmation that the quota unit entitlements have been endorsed on the licence.
